Hello, my name is \_\_\_\_\_ and I'm calling about humane ordinance (O2017-8598) to ban horse carriages in Chicago. I'm asking that you support this humane measure sponsored by Alderman Reilly and urge Alderman Emma Mitts to put it on the Agenda in the Committee on License & Consumer Protection.

This issue is important to me because (please use your own words – below are some reasons you can use:)

- 1) Numerous horse carriage accidents in last 3 months (around the world) where at least 3 humans & 4 horses have died – no city or region is immune to these tragedies
- 2) Chicago's 3 carriage companies have been documented working horses when too hot many times (90 degrees +) (as recent as June 16 and Memorial Day), overworking horses by more than double the time allowed (12+ hours), not providing water at times and violating laws that impact public safety & many more
- 3) The carriage companies have been to court for hundreds of citations & upwards of 200K in possible accompanying fines – none of this is stopping the drivers from continuing to break the law
- 4) You love or would love to visit Chicago but will not spend your tourism \$\$\$ here until we ban the archaic, inhumane, dangerous & unnecessary horse carriages
- 5) At least 20 Aldermen support the ordinance/ban
